The Dallas Federal District jury returned a verdict of no negligence for our client.

An employee of our client was changing the baby's diaper on a counter, when the baby rolled off the counter and landed on a hard floor fracturing the child's cranium. The Dallas District Judge dismissed the Plaintiffs' lawsuit with prejudice before the jury could hear any evidence in the case.


